Biding mechanics:

- 1. The bid form may be obtained personally from the Disposal Committee starting February 07 12, 2025 (8:00 AM to 5:00 PM) at the Facilities and Administrative Support Department (FASD), 4th Floor, BDO Plaza, 8737 Paseo de Roxas, Makati City. It can also be downloaded through the SHFC website at https://www.shfc.dhsud.gov.ph/.
- 2. Bid proposals shall use the bid form obtained from the FASD. The bid form shall be accomplished in **one** (1) **original copy** and shall be submitted in a properly sealed envelope addressed to:

- 3. Bids must be accompanied by the Invitation to a Public Auction with signature and/or conforme on the last page as a proof of understanding the mechanics of public auction; and bid bond/s in the form of cash, manager's check or cashier's check acquired from a reputable bank. All checks should be payable to the **Social Housing Finance Corporation**.
- 4. Individuals, partnerships and/or corporations are qualified to participate in the Public Auction subject to the submission of **Latest Mayor's** / **Business Permit**.
- 5. Interested bidders/parties may conduct **ocular inspection** of the abovementioned unserviceable office equipment and parts of the motor vehicles starting **February 7, 2025** from 10:00 AM until 02:00 PM only at the warehouse located at 26 Laura Drive 1st Avenue Bagumbayan, Taguig City. Interested bidders shall be accompanied by FASD Personnel during said ocular inspection.
- 6. Bid proposals shall be submitted not later than February 13, 2025 until 10:00 AM only. The Public Auction shall be conducted on "As is, where is" basis subject to other terms and conditions which the Disposal Committee may impose. Late bids shall not be accepted. The opening of the bids will be on February 13, 2025 immediately after the deadline at the 5th flr SHFC Board Room.
- 7. The envelope containing the bid form and other requirement should be sealed and signed by the bidder and properly labeled containing the name of the bidder and the project disposal to be bid. The bid tenders that are not in the prescribed form or format (e.g. unsigned bids, etc.) and/or those not accompanied by the signed Invitation to Bid and/or bid bonds at the time the of opening of bids shall be considered defective bids which automatically disqualify the respective bidder.





- 8. A bidder may be allowed to withdraw a bid tender before the time of opening of bids. The bid/s shall be returned unopened. Changes shall not be allowed on the bid forms after the deadline for the submission of bids.
- 9. Sealed bids shall be dropped in the bid box located at the Facilities and Administrative Services Department, 4th floor, BDO Plaza, 8737 Paseo de Roxas, Makati City. Bids will be opened in the presence of all bidders or their duly designated representative/s and COA representative.
- 10. The winning bidder shall be the proposal with the highest offered price which shall not be lower than the floor price. The declaration of the winning bidder shall immediately follow. The winning bidder shall pay the bid bond to the Cashier Section at the 2nd floor of BDO Plaza afterwards and shall submit a photocopy of the Official Receipt (OR) to the Disposal Committee Member before issuance of the Notice of Award. Bid bond of non-winning bidder/s shall be returned outright after the declaration of the winning bidder.
- 11. Should there be a tie in the highest offered price, the concerned bidders shall participate in a "toss coin" to break the tie.
- 12. The winning bidder's bond shall automatically be considered as a partial payment and the balance shall be paid in full to the Cashier Section in the form of cash, manager's check or cashier's check acquired from a reputable bank within fifteen (15) calendar days from the receipt of the Notice of Award.
- 13. In case of failure of payment of the bid price within the required period, the award shall be canceled and the bid bond shall be forfeited. The bidder shall also be blacklisted and shall not be allowed to participate in future auctions for a period of one (1) year from the date of award. The subject items for disposal shall be awarded to the next highest bidder.





- 14. The Official Receipt (OR) showing full payment of the bid price shall be presented to the Head of Facilities and Administrative Services Department (FASD) which shall serve as the basis for the preparation of the Gate Pass within five (5) days upon receipt of the OR.
- 15. The highest winning bidder shall be responsible for the expenses incidental to the cost of hauling the items subject for disposal. The awardee has twenty (20) calendar days from the receipt of the Notice of Award to clear the area where the items are located. In case the winning bidder fails to complete the pick-up/hauling of the property within prescribed period, the award shall be revoked/canceled and the bid bond will be forfeited. The bidder shall also be blacklisted and shall not be allowed to participate in future auctions for a period of one (1) year from the date of award. The next highest bidder shall be awarded the bid, so forth and so on.
- 16. Failure of bidding shall be declared if all prospective bidders are declared ineligible; no bids are received; all bids fail to comply with the bid requirements; all bids are below the floor price; the winning bidder refuses to accept the award or the winning bidder fails to make the payment on time
- 17. The FASD-SHFC reserves the right to reject any or all bids, or part thereof, waives any formality, requirements or defects contained therein and will accept the offer it considers most advantageous to the government.
