SHFC awards land titles to Metro Manila, Rizal families

A total of 141 households from Metro Manila and Rizal Province can finally call themselves landowners as they received their respective transfer certificate of title (TCT) from Social Housing Finance Corporation (SHFC) in a ceremony held at the GSIS Gym in Pasay City on August 28. Led by SHFC President Atty. Arnolfo Ricardo Cabling, the awarding is part of the celebrations for the 31st anniversary of the Community Mortgage Program (CMP), the agency's flagship initiative.

The new title holders, who have fulfilled their loan obligations with SHFC, are now part of more than 300,000 families who have attained land tenure security since the inception of the CMP in 1988. They come from cities which have huge housing needs and which have shown strong support for the program, namely Angono, Antipolo, Caloocan, Las Piñas, Manila, Marikina, Parañaque, Pasay, Pasig, Quezon City, and Valenzuela.

Also gracing the event as keynote speaker was Senator Francis Tolentino, Chair of the Urban Planning, Housing

"This awarding ceremony today is a testament to the innovativeness of SHFC and other housing agencies prior to the creation of the Department of Human Settlements and Urban Development," he said. HDH projects score high in resettlement study

A study presented at the 7th Asia-Pacific Housing Forum in Makati on July 29 found that communities in seven projects under the High Density Housing (HDH) program are faring way better than other resettled communities. The presentation "Gainers or Losers?: The Resettlement Experience of Metro Manila ISFs" given by Segundo Joaquin Romero, PhD of the Ateneo de Manila University, shows that SHFC-assisted communities are all "gaining" after relocation.

Pascualer Ville, Bistekville, Ernestville, and Goldmine Interior, all located in Quezon City, garnered a Level 5 rating (gaining, with minor challenges) in the Community Transformability Assessment used in the study. Even its off-city project in Bulacan, ALPAS HOA, obtained a Level 5 rating. Thus, of the eight relocated communities rated Level 5 the highest possible score - five were undertaken under the auspices of SHFC. AMVA Housing in Valenzuela City, on the other hand, got a Level 4 score (gaining, with major challenges). Of the 13 communities found to be worse off after relocation, none were those of SHFC.

The high rating of SHFC communities

243 Sultan Kudarat families to start new life after P21 million loan takeout

The journey of 243 informal settler families (ISFs) from Tacurong City, Sultan Kudarat to have their own land started rolling as SHFC awarded the check for the purchase of the property where they will relocate to. The P21-million check was handed over by Jane Melodias, OIC-Manager of the General Santos City office, to the landowner in a ceremony on August 17.

The takeout, which came just two months after SHFC awarded the letter of guaranty on June 14, allows the purchase of a 4.78-hectare land in Purok Buenaflor owned by Wilfredo

700 multi-cultural families to benefit from Mati City housing project

The construction of a housing project that will benefit more than 700 families in Mati City got underway on June 29 in a groundbreaking ceremony jointly led by SHFC and the Davao Oriental provincial government. Projected to be completed by next year, the units will be built on a 15-hectare property in Barangay Don Martin Marundan for members of the Mandaya, Muslim, Bisaya HOAI.

The event took place after Atty. Arnolfo Ricardo Cabling and Gov. Nelson Dayanghirang signed a memorandum of agreement under which SHFC will finance the project, which will house 256, 247, and 240 partner-homeowners from Phase 1, Phase 2, and Phase 3, respectively. Atty. Ronaldo Saco, OIC-Vice President for Mindanao Operations, and Cong. Joel Mayo Almario also graced the occasion.

Each partner-homeowner will pay P2,800 a month for 25 years under CMP, which aims to improve the living conditions of underprivileged

SHFC, CMP earn GADtimpala citations Change of fate for Marikina for gender equality efforts

SHFC was recognized as one of the outstanding government agencies that promote gender sensitivity and mainstreaming, winning a GADtimpala citation from the Philippine Commission on Women (PCW) during the 10th anniversary of the passage of the Magna Carta for Women or Republic Act 9710 on August 14. The law aims to make governance gender responsive. The agency's flagship initiative, CMP, was also awarded a citation. It was the only organization to receive two citations.

The awards were in recognition of SHFC's efforts in pursuing gender equality and women's empowerment within the organization and among its clientele. Atty. Maria Rosalie Richa Taguian, Vice President for Program Development and Enhancement, received the plaques during the ceremony held at the Philippine received the International Convention Center.

"The citations that we got is proof that we are really determined to make an impact on gender equality and women

empowerment,' Atty. Taguian said. "It is not just paying lip service, it is more of how can we use the CMP to make sure that we really make an impact in the ground and women have access to financing."

Macaspac, Cezar OIC-Manager for d Community and

GADtimpala stands for "Gender and Development Transformation and Institutionalization through Main-Programs, streaming of Agenda, Linkages and Advocacies". Qualified agencies undergo rigorous and thorough validation process conducted by PCW.

SHFC was among the more than 20 agencies that were screened for the award and made it to the final 13.

SHFC, as a government-owned and -controlled corporation, adheres to enhancing the role of women in the organization and to promoting gender equality in its housing programs.

Weathering the storms of life, Dulce Abusman shares CMP success

Dulce Abusman, or simply "Dulce" to her colleagues, has weathered life's storms literally and figuratively. She had to become the breadwinner of her family when her father passed on prior to her entrance to college. Armed with a fighting spirit and deep-rooted dedication to her family, she singlehandedly sent her two siblings to college, and they are now both licensed civil engineers.

"Nakaka-fulfill lang na nakapagpatapos ka ng kapatid mo at successful pa," Dulce said. "Lahat ng pagod mo nag-paid off, nabawi." It was such a fulfilling and heart-warming experience for her that it has become inherent for Dulce to help out in whatever way she could. In fact, she unreservedly continues to financially support her nieces and nephews on their college education.

Her dedication not only shines through what she has done for her family but also through her work in SHFC, her other family. After graduating with a degree in BS Commerce (Major in Accounting) and passing the licensure examination for teachers with a specialization in mathematics, Dulce started working with the agency in January 2007 as a Senior Accounts Specialist. She was assigned in the Accounts Management Department and handled Luzon accounts. In the 12 years Dulce had been doing collection and account servicing for CMP, she experienced so many things that seemed to test her will and commitment-from angry mobs of partner-homeowners to calamities.

Dulce shared her most unforgettable experience doing CMP work: her team conducted an orientation to partner-homeowners in Marikina in the middle of the catastrophic Typhoon Ondoy, which hit Manila in September 2009. They had considered cancelling the activity because of the impending typhoon. But their sense of duty prevailed especially because the homeowners association (HOA) pleaded that their team come and continue with the plan. And so they pushed through with the orientation even at great risk to their lives.

When they got to Marikina, immense rains were falling and roads were swarmed with rushing waters. Despite the situation, Dulce's team stared and persevered. "Tinapos na namin (ang orientation) dahil nandoon na 'yung mga tao and nag-aantay sila sa natin," programa she shared. Unfortunately, due to the pouring rains and heavy flooding, they got stranded in Marikina after the activity. Her team spent the whole night cramped inside the corporate vehicle and was only able to leave the city the next day when the roads were once again declared passable. "Nakakatakot yung experience noong Ondoy kasi first time kong naka-experience ng ganung ulan at baha." Through lots of prayers, the team survived the storm through the night and all of them got home safe to their respective family.

Dulce believes in prioritizing the HOAs with the lowest Collection Efficiency Rating (CER) and on focusing their





team's visits. orientations. and collection campaigns on those communities who could improve their CER. "Tiyagain mo lang puntahan at ipaliwanag ang responsibilidad nila bilang miyembro ng komunidad at sa CMP," she said. "Kausapin mo lang at ipaliwanag sa paraang mas maiintindihan nila." Dulce added that thoroughly explaining the computation of the statement of account (SOA) also encourages partner-homeowners to pay their monthly amortization.

This strategy proved to be effective when her team exceeded their 2017 collection target and reached a 129 percent increase. This success was brought on by their constant follow ups with the partner-homeowners, visits to the sites for the collection campaigns, and teaching sessions with them on how to check and understand their SOAs. Dulce's team also inculcated a of sense responsibility among partner-homeowners in paying their monthly amortizations religiously. She added, however, that the collection must be improved continuously to help more families secure land tenure.

Dulce is hoping that CMP will expand to more areas in the country in order to serve more marginalized families.

After scrimping and working hard most of his life, Manuel Salamanca, a partner-homeowner from the L. Francisco HOAI, is finally living his dream of having his own land title.

But just like any doting father, his most precious dream still involves his family. Under the IRR, the department shall be 11201 was passed in Congress in the main planning and policy-making, November 2018 and was signed into law the main planning and policy-making, regulatory program coordination, and performance monitoring entity for all housing, human settlement, and urban development concerns. It also provided for the creation of the National Human Settlement Board, which shall act as the policy-making body and provide program directions to the attached agencies. Aside from SHFC, these agencies include NHMFC, HDMF, and the National Housing Authority.

In his remarks at the ceremony, which was also attended by the law's principal authors former Senator Joseph Victor "JV" Ejercito and former Negros Congressman Alfredo Occidental "Albee" Benitez, del Rosario said the DHSUD is President Rodrigo Duterte's "whole-hearted gift" to the Filipino people.

The initiative is a collaboration between the agency and the Presidential Commission for the Urban Poor (PCUP), which provided assistance to ensure the adequate relocation of the families affected by an impending demolition. PCUP organized the ISFs to become a legitimate association, a requirement under their application for the CMP.

"We only desire that the commission would be able to help our urban poor and find them a decent relocation," PCUP Chairperson and Chief Executive Officer Alvin Feliciano said. "President Rodrigo Duterte has always asserted the no-relocation no-demolition policy."

SHFC has been advocating an on-site, in-city or near-city resettlement to ensure that affected families maintain their access to livelihood and other basic services which are found in urban areas.

is an affirmation of the corporation's participatory and community-driven approach in its HDH program, a slum redevelopment strategy wherein a significant number of informal settler families are accommodated in multi-storey buildings. The agency is a strong advocate of in-city or near city arrangement to ensure the continued access of families to economic, educational, and cultural opportunities that abound in the metro.

Commissioned by the Department of the Interior and Local Government, the study of 30 sites in Metro Manila and Regions III and IV-A seeks to determine the social impact of the Alternative Housing Program and People's Plan Fund. This is designed to provide decent shelters and safer settlements to vulnerable families, particularly those living along waterways and danger zones.

The study looked into seven dimensions of community well-being such as shelter and living space, mobility and access, income and livelihood, social services, social networks and safety nets, community governance, and integration into the receiving local government unit.

Cong. Benitez's inspirational convergence speech

Below is a transcript of the speech delivered by Negros Occidental 3rd District Representative, Francisco "Kiko" Benitez, during the Socialized Housing Convergence held at the Landbank of the Philippines Building in Manila on September 5.

On behalf of Cong. Strike Revilla, chairperson of the Committee on Housing and Urban Development, we would like to congratulate the SHFC family for 31 years of unwavering service to the Filipino people, especially for those who need the basic right to shelter and housing. Let me commend the agency for staying true to its vision to provide flexible, affordable, innovative, and responsive shelter solutions to the homeless and low-income families in partnership with national and local

government, and civil society organizations. Your programs, such as the Community Mortgage Program, which we are celebrating today is a wonderful testament to the *"bayanihan"* spirit of the Filipino people. This inspires us to believe in the goodness and generosity of our communitarian spirit as Filipinos.

In 1972, the United Nations held its first environmental conference in Stockholm. Sweden. Our representative was Elena Z. Benitez, who brought back the idea that human settlements was the linchpin framework by which people and communities interacted with the environment and the world around them. She was also the representative in 1976 at the First Habitat Conference, which led of course in 1978 to the creation of the UN Habitat and Human Settlements. She brought back the idea of human settlements with the development of UN Habitat in the Philippines and tasked my late father, Jose Conrado Benitez, to study how such a framework might be useful for Philippine development. He had always been an advocate of the right to decent and affordable housing. In fact, he used to say that all development had to have an address, a face, and a home because human settlements is actually the linchpin of social development. It is thus with great joy that I hear the initiative for Socialized Housing Convergence that is being launched today.

Because I believe that human settlements and urban development is a concern for everyone. It is one that provides us not only with shelter and a roof but also a home: a home that must also have not only water and electricity but mobility and transport, access to education and health services, and so on and so forth. It is in fact a foreground for how you should measure the capacity of the Filipino people to be brought up in progress and development. In addition, the establishment of mass housing, my father's initiatives included shelter financing, which

remains relevant today. These include the Home Development Mutual Fund and the National Home Mortgage Finance Corporation, the mother agency, which gave birth to SHFC.

It is not that surprising that for his part, my brother, the former representative of the 3rd district of Negros Occidental Albee Benitez never wavered in promoting the rights of the people to secure housing. He advocated for the establishment of sustainable and safe settlements for every Filipino community that lives on trust and contributes to the development of the nation. It was under his watch and of Sen. JV Ejercito that the Department of Human Settlements and Urban Development Law was approved. Looking at the common legacy that they have passed from Tita Helen, my father, and to my brother, I know we have big shoes to fill.

This is why I would like to assure you [that] we at the House of Representatives, share your vision in addressing homelessness and the inability of our countrymen to afford basic dignified needs. We have pushed for the enactment of the department and we are currently trying to push to make sure that there is more funding given to the housing agencies so that at the very least the reorganization can be properly funded. I have also filed House Bill No. 42 or the Local Government-Led In-city or Near City Settlement Act, which has a provision to make people's planning and consultation very much a part of the process of resettlement. Hopefully, this will ensure the sustainability of resettlement sites by assuring access to services and employment, as well as empowering the informal settler families by making them active partners in the planning and management of these sites to make real the significance of the convergence that we are celebrating today.

If enacted into law, I foresee the active involvement of SHFC not only in providing housing loan under the CMP and the High Density Housing program, but more importantly in helping the families form themselves

into associations for accreditation in these housing programs and in helping them design their own produced plans. To create such organizations and to make communities truly empowered, I think it should be a desire that we all for. The House aspire of Representatives is also in the process of crafting the General Appropriations Act. Rest assured, that we will fight for the needs of the department and its attached agencies, including hopefully increasing the budgetary support for SHFC. I have just been informed that there is a proposed bill for the charter of SHFC, which we will review and probably will try to see if we can file next week. At least those are the limits by which the scope of my responsibilities can help.

Indeed, every Filipino deserves a shelter and a home, which can be a site in which basic dignity and decency can prosper. So together, let's work on achieving your vision of convergence and the provision of safe and secured homes to the homeless—a home where opportunities will enable them to rise from poverty in a sustainable and inclusive manner. After all, ang sabi din po ng tatay ko: "Higit sa lahat, ang tao."
