BOARD RESOLUTION NO. 822, SERIES OF 2019 APPROVAL OF THE MANAGEMENT PLAN-OF-ACTION ON THE MARAWI SHELTER PROJECT WITH REGARD TO LAND DEVELOPMENT AND OTHER RELATED MATTERS

WHEREAS, the Management reported on the updates on the Marawi Shelter project particular to the following issues and concerns, to wit:

- Progress report updates on site development phase 1 on the Matua Ampuan property and proposal of construction of a retaining wall and coconet engineering solutions to the site;
- Settlement of land dispute with regard to the Wahab Rodi property;
- Purchase of additional property;
- Updates on the Macondara property;

WHEREAS, the Management also discussed the recent developments of the project, to wit:

- I. Updates on the Site Development Progress for Marawi Shelter Project Phase I on the property of Matua Ampuan at Brgy. Dulay, Marawi City, as shown:
 - a. Subdivision Plan with profile of the project;
 - b. Cost Estimate submitted by the Contractor- Periodic Accomplishment;
 - c. Relative Percentage Weight with Drawdown Schedule;
- II. Proposal of Retaining Wall as a Mitigating Measure to the site:
 - a. Trapezoidal Grouted Riprap;
 - b. Coconet Bio-Engineering;
- III. Update on the property for Marawi Shelter Project Phase II
 - a. The Property of Wahab Rudi with an area of 67,571.70 square meters will be the Marawi Shelter Project Phase II;
 - b. Located at Brgy. Dulay, Marawi City and approximately 600 meters from Marawi Shelter Project Phase I;
 - c. It can accommodate more or less 405 home lots at 100 square meters lot size at 40% of the total area as open spaces that include roads;

d. The Board deferred the issuance of Notice of Award/ Notice to Proceed of the winning bidder, Fiat Construction Services, due to some complaints from the children of one of the dead heirs of Wahab Rodi;

WHEREAS, likewise, the Management reported on the reconsideration on the purchase of the Macondara Property as the third property for the remaining requirements of the Marawi Shelter Project;

NOW THEREFORE, be it resolved as it is hereby resolved, that the Board approves as it has hereby approved, the Management Plan-of-Action consisting of the following items, to wit:

- 1. The construction of a retaining wall and Coconet Bio-Engineering solutions on the Ampuan Property amounting to Php12,844,450.09;
- 2. The awarding to FIAT Construction Services for the Site Development of the Sultan Wahab Rodi property; and
- 3. The authority to purchase additional properties with a total lot area of 81,001.62 sqm.;

RESOLVED FURTHER, with regard to the Macondara Property, the Management was instructed to conduct the following:

- The Barangay Officials with jurisdiction over the Macondara Property shall sign an undertaking certifying that there is no conflict and adverse claim on the property, if any, and
- The project contractor/developer shall sign an undertaking for the registration of the property and the development of the Road Right of Way (RROW);
- The above stated documents shall be presented in the next scheduled January 2020 Board Meeting, and subject to Board review and approval;

RESOLVED FURTHERMORE, that the Board shall be regularly apprised of the developments on the matters concerning the shelter project;
