- 2. Two (2) **VALID ID's*** of the MB;
- 3. Two (2) **VALID ID's*** of the representative/s;
- 4. CA BOARD RESOLUTION prior to release of the title (Corp. Circular CMP #: 08-007, S. '08).

iii. IF FULL-SETTLEMENT THROUGH INSURANCE (MRI):

- 1. **EXTRA-JUDICIAL SETTLEMENT OF ESTATE** (EJS) or Affidavit of Self-Adjudication, as appropriate;
- 2. **AFFIDAVIT OF PUBLICATION** of the EJS or affidavit;
- 3. Two (2) **VALID ID's*** of all the heirs of the deceased
- 4. SPECIAL POWER OF ATTORNEY (SPA), if any;
- 5. Two (2) **VALID ID's*** of the representative/s, if applicable;
- 6. CA **BOARD RESOLUTION** prior to release of the title (Corp. Circular CMP #: 08-007, S. '08).
